I am reminding everyone reading this email that in the past, Mr. Rogalski had made me understood that as an “Assistant Legal Attaché”, he was “one of the FBI representatives in Beijing” as you can see in the email he sent to me September 20, 2021, and which can be visualized at this URL:

If Mr. Rogalski is not working anymore as an Assistant Legal Attaché at the U.S. Embassy in Beijing, may I ask why, as a victim of the criminal enterprise orchestrated by McDonald’s Corporation, haven’t I been notified of who was replacing Mr. Rogalski?
